Separate sealed Bids will be received by Wayne County to provide the erosion control, grading, storm sewer, sanitary sewer, curb and gutter, asphalt pavement and markings, etc. for above referenced project, as detailed within the Construction Drawings for "Ivey Drive," as prepared by B. R. Kornegay, Inc., last revised January 18, 2023.

Firms that wish to bid on this project as the prime contractor must be prequalified as a Bidder or PO Prime Contractor prior to submitting your bid. Sealed bids will be received by Wayne County, 224 E. Walnut Street, (4th Floor Commissioners Meeting Room Goldsboro, NC 27530 until 2:00 pm (EST Manager's Office Clock), Wednesday, May 17, 2023, and then officially opened and read aloud at Wayne County, 224-226 E. Walnut Street, (4th Floor Commissioner Meeting Room) Goldsboro, NC 27530.

Following the **Pre-Bid Advertisement on Monday, April 24, 2023**, a **NON-MANDATORY Pre-bid Conference will be held on Wednesday, May 3, 2023, at 2:00 p.m.** at Wayne County Court House, 224-226 E. Walnut Street, (4th Floor-Commissioner Meeting Room) Goldsboro, NC 27530. Following a brief overview of the project, the pre-bid attendees may then visit the project site located along Ivey Drive. This visit will "not" be guided - it is strongly recommended that the proposing contractor visit and familiarize themselves with the site prior to preparing their bid.

Anticipated contract award date is *approx. June 30, 2023*.
