Sealed proposals will be received by the North Carolina Department of Transportation (NCDOT) on **July 27, 2023 until 11:00 AM at NCDOT Facilities Management Unit, 1 South Wilmington Street, Raleigh, NC 27601, Attention to Mr. David Varel**, for the furnishing of labor, material and equipment entering into construction of the **Century Data Center HVAC Upgrade**, at which time and place bids will be opened. This project consists of installation of three (3) new indoor computer room air-conditioning (CRAC) units and one (1) indoor wall mounted air-conditioning unit and associated outdoor condensing/condenser units to condition the data center and UPS electric room within the NCDOT Century Data Center. Contractor is recommended to hand deliver or use private courier; do not use US Postal Service due to building address delivery logistics for USPS mailing address at this facility.
