Summary of Discussion

1. Thank everyone for their interest in the project and attendance at the pre-bid meeting.

- 2. Introduction of Johnston County Public Schools (JCPS) Owner team and Design Team (Dewberry Engineers Inc.):
 - a. Josh Woodard (JCPS) will be the primary Owner Representative
 - b. Chris Herron (Dewberry Engineers Inc) will be the primary Design Team Representative
 - c. Rebecca Parada (Dewberry Engineers Inc)
- 3. Bid Document Access: Ask if everyone was able to access the bid documents.
- 4. Project Scope of Work:
 - a. Replacement of existing BAS Controls systems at West Johnston High School, Selma Elementary and Corinth Holders Elementary School.
 - b. Selma Elementary Replace (2) hot water secondary pump motors. Provide new VFDs.
 - c. West Johnston High Replace (2) hot water and (2) chilled water secondary pumps. Provide new VFDs. Replace (1) fan coil unit.
 - d. Corinth Holders Replace (1) HVAC Package Unit serving Gymnasium. Scope of work was discussed/presented at PreBid Meeting. Further details on this unit replacement will be coming in future addendum no later 6/20/23. Also, see comments below.

5. School Schedule:

- a. This is a traditional calendar school. Work is intended to be conduct primarily around the summer break, with weekends and nights during school year, if necessary
- b. Depending on how the school year develops later in the year, there could be school events that will need to be scheduled around. Further discussions will take place and a list of events and dates shall be provided by JCPS Owner Representative, if necessary.

6. Alternates:

- b. Alternate #2: Manufacturer Preferred Brand Control Valves: Belimo

7. Unit Prices:

a. No Unit Prices for this project.

8. Allowance/Contingency:

 a. Project includes a \$50,000 contingency/allowance for the owner to use toward their discretion. Any contingency/allowance shall be returned to owner during the project closeout process.

10. General Conditions:

a. The General Conditions of the contract apply to all portions of the project. This is a formal bid, so all standard JCPS policies must be followed.

a. The General Conditions in the project manual requires all contractors working on JCPS property to submit a "Sexual Offender Registry Check Certification Form". The successful Contractors, including all sub-contractors, will be required to submit this form when submitting the contract. Contractors are required to complete this information before they will be allowed on the school property.

12. Photo ID Requirement:

a. JCPS requires all workers to wear a generated Photo ID, at all times, while on site.

a. Contractor shall be permitted to use existing water and power. These utilities shall be left as when the project began.

22. Contractor Questions:

- a. What do you mean by "recommission" for AHU-6B at West Johnston High School?
 - i. Get it back in working order and programed correctly. This includes cleaning the energy recovery wheel.
 - ii. Any deficiencies beyond what is mentioned in the project will need to be recorded to discuss with engineer and owner. Additional costs will come out of the contingency.
- b. How is the glycol system supposed to be flushed? Answer will be coming in the next addendum.
- c. Are the existing control valves at Corinth Holders Elementary School being replaced?



i. Yes, the existing control valves (pictured below) will need to be replaced.





- d. The mezzanine at Corinth Holders Elementary School does not appear to be plenum rated and has a lot of exposed wires. Does the wire have to be plenum rated? Does all wiring need to be in conduit? Answer will be coming in the next addendum.
- e. Will the concrete pad the existing gym unit at Corinth Holders Elementary School need to be expanded? This will be indicated on the revised documents in the next addendum.
