Will inmates be in the area during work?	No, construction will happen in phases – When construction begins one of the entire floors of the unit will be emptied of offenders. When the construction on that floor is complete the building will be inspected, given beneficial occupancy status then construction may begin on another

Can a dumpster/dump truck be placed on site?	A dumpster/dump truck will be allowed in the parking lot for the disposal of waste. This dumpster/dump truck must be empty at the end of each day.
Was the handrail repair added to the contract?	Yes, the handrail repair was added to the plans for each section where needed.
Are there bathroom facilities onsite for the construction crew?	Yes, the construction crews will be allowed to use the facilities in the building that they are working in.
What is the procedure for lunches?	The crews can bring in their lunches or go out to eat. If food is brought in it must be in clear containers and pass through the gatehouse.
What additional training is needed to enter the facility?	All members of the construction crew must complete PREA training prior to entering the facility. This is to include anyone driving a dump that will come in the facility more than once.
Do we call for the pipes to be painted in your specifications? If I need to specify it – please give me your recommendation for paint finish.	New pipes are not to be painted as part of this work.
The new pipe connections are No Hub connections – are these types of connections more susceptible to damage from the offenders – will they be able to stand up to abuse?	If the Contractor would prefer to use hub & spigot cast iron with elastomeric gaskets, I will except that. But the pipe must be cast iron. PVC pipe will not be accepted.
Inside the chases behind the showers – does the pipe insulation need to butt the wall where the pipe penetrates, or does it need to be stuffed into the penetration?	The new shower heads are connected to the metering valve with 3/8" plastic tube that is not intended to be insulated. I don't know of any other pipe we have penetrating a wall. But if so, termination at the wall will be acceptable.
There are several pipes in the chase that are missing insulation – do we need to worry about these at all?	Only insulate piping that is part of the new work.

- a) Renovation of the existing offender showers at Pasquotank CI, Units 2, 3, and 4, (36 units total).
- b) Demo the existing floor and wall finish, demo thick set floor tile down to structural concrete slab.
- c) Install new thick setting bed forming slope to floor drain, epoxy floor and wall system.
- d) Install new shower heads and controls.
- e) Replace existing painted steel HVAC screens with Stainless steel screens.
- f) Demo existing hollow metal window units, install new.
- *Project Length The total completion time is <u>336</u> consecutive calendar days from the date of the Notice to proceed to Final Acceptance.
- *Liquidated damages will be accrued at the rate of \$500/day on this project.
- *Water, Sewer, and power are provided from owners existing system without metering and without payment of use charge. Contractor to provide connections and extensions of services as required for construction operations.

 - 1. The Contractor shall use extreme caution when moving equipment in or out of the project site and buildings and shall coordinate these activities with the NCDAC Site Representative.
 - 2. Absolutely no shipments of materials, etc., will be received or cared for by any NCDAC personnel at the facility. Shipments coming into the site after working hours will not be received and will be sent back for delivery the next working day.
- 8.4 Temporary Controls: The Contractor will use orange mesh fencing or other approved means to segregate and control the work area.
