Welcome to the National Institute of Minority Economic Development (the Institute) Executive Networking Conference (ENC 2023). This year's theme: "Business & Capital Reimagined: Resources, Opportunities & Investments (ROI)," is designed as a call to action to challenge businesses and venture capitalists to think outside the box and "reimagine" a new or different way of doing business.

With this year's lineup of speakers, the Institute is leading the charge to reimagine and engage in a new era of business exploration. For example, we have **Her Excellency Ambassador Elsie S. Last year was an exciting growth year for the Institute as we officially hit fifty FTEs for the first time in the organization's history. Through our four lines of business, we achieved several milestones: officially recorded **\$22MM in grants to small businesses** through the RETOOLNC program, \$38MM in bonding and awards, and \$33MM in loans and access to capital.

This year the Institute will endeavor to launch a new community development corporation to reclaim our heritage from the legacy of the North Carolina Community Development Initiative. The CDC will be known as the **Institute Community Development Initiative** (the Initiative or ICDI). ICDI will focus on supporting existing CDCs to grow their capacity and provide technical assistance and operating support.

Attending ENC is an **investment in business** and self. Your call to action–lean in, engage, reimagine, network, and explore all the opportunities provided during ENC 2023. The sessions this year are some of the best we've ever presented, and our mission is to ensure your **Return On Investment (ROI)** and maximize your business opportunities. The Executive Networking Conference (ENC) was established in the mid-1980s as a means of building relationships and supply chain opportunities for minority business executives. 
