Attention Partners: This is a Request for Quotes notification for the P040014 SCDOT I-26 Corridor Improvement project. Lane Construction is bidding on this project and is seeking quotes from subcontractors and suppliers on portions of the work. Quotes are due February 09, end of business day.

PROJECT DESCRIPTION:

The South Carolina Department of Transportation is studying improvement options along Interstate 26 from interchange Exit 125 at Old Sandy Run Road to Exit 136 at Caw Caw Road. The improvements will focus on increasing capacity to relieve congestion, enhancing safety, and improving freight mobility along the 9-mile corridor. Two (2) interchanges and the associated frontage road access points will be reconstructed, and three (3) overpass bridges will be replaced.

SCOPE OF WORK:

This project consists of Roadway: earthwork/grading, clearing, trucking of materials, drainage, asphalt paving hauling, base course, pavement markings, traffic signs, excavation, geotextiles, drainage pipe materials, miscellaneous concrete flatwork, aggregates/rip rap, guardrail, concrete barrier, temporary barrier, erosion control, seeding, landscaping, signals, demolition/sawcutting of existing bridge. Structures: prestressed concrete girders, structural steel girders and diaphragms, ready-mix concrete, compression seal joints, grooving, reinforced steel, drilled shafts, H-Piling, structural excavation, barrier parapet, concrete slabs, elastomeric bearings, shaft load tests/CSL setup, and retaining walls. There are many other scopes of work and opportunities available.



Lane Construction welcomes participation from DOT certified DBEs on this bid build project. The Lane Construction Corporation is willing to break out parts of this contract's work items into economically feasible units to facilitate DBE subcontractor participation. Lane Construction is willing to negotiate in good faith with interested DEB subcontractors, and Lane will not reject DBE, as being unqualified without sound reasons based on thorough investigation of their abilities. Lane Construction will work with minorities on issues related to bonding, insurance, lines of credit and equipment. If you are not a DBE subcontractor but can provide DBE participation (with 2nd-tier DBE subcontractors or DBE suppliers participation) in your quote, that would be greatly appreciated. DBE goal for this project is set at 7.5%.
