Project Description:

Park Economy 3 Expansion Program: Approximately 110 acres, 8,000 parking space expansion to the Park Economy 3 lot at RDU International Airport. Project consists of site development, new utilities, and construction of new parking facilities. Project also includes renovations to the existing Park Economy 3 lot and construction of a new 12,000 sf Customer Amenity Building.

Runway 5L-23R Replacement Program: This project will replace the existing Runway 5L-23R with a newer longer runway parallel to the existing approximately 600 feet to the west. This project consists of approximately 5,000,000cy of earthwork to establish the new runway subgrade and then the construction of a new 10,639lf runway. Once the new runway is constructed the existing runway will be removed and replaced with a new taxiway. The program also includes the realignment of Lumley Rd. to allow for the new runway location.

Project Scope

These projects involve significant civil/sitework requiring experienced construction material testing services. The CM at Risk for each project will select firms to join the CM at Risk teams. The CMR may select a single firm or may award multiple firms. Balfour Beatty / Metcon – RDU is the CM at Risk for the Park Economy 3 Expansion program and Balfour Beatty is the CM at Risk for the Runway 5L-23R Replacement program. The projects will be contracted separately even if a single firm is chosen.
